Oral History Interview with Yeandres Rivera González

PREFACE

The following oral history is the result of a recorded interview of Yeandres Rivera González conducted by Giovani Bonilla Martínez on February 26, 2022. This interview is part of course work done by students at the University of Puerto Rico at Mayaguez.

Readers are asked to bear in mind that they are reading a transcript of the spoken word, rather than written prose.

Giovani: Greetings. My name is Giovanni Bonilla. Martinez and I will be your interviewer for this session. We are currently located at a friend's apartment in the town of Mayaguez, Puerto Rico. To start off, I want to begin by asking some general questions. First, do I have your permission to record audio for this interview?

Yeandres: Yes, you can.

00:00:25

Giovani: Thank you. Now, what is your full name?

00:00:29

Yeandres: My full name is Yeandres Rivera Gonzalez.

00:00:34

Giovani: Can you spell your first name for me?

00:00:35

Yeandres: Yeandres.

00:00:43

Giovani: Where does that name origin from?

00:00:45

Yeandres: So my mother told me that uh when I was uh uh wum uh, I was in the in the belly of my mother. She told me that in that era, the the trend of names was Giancarlo, Jean Paul, Jean Andrés. But she wanted to give it a twist. So, she give it a mix from the name Jean and also the name Andrés. And she put those two names together and she called me.

Giovani: Okay, that's very interesting. How old are you?

00:01:30

Yeandres: I'm 21 years old.

00:01:32

Giovani: When were you born?

00:01:33

Yeandres: March 6th of 2000.

00:01:36

Giovani: Okay. In what town? If you were born in Puerto Rico, were you born and raised.

Yeandres: San Juan, Puerto Rico. I was born there, but I was raised in Toa Alta, Puerto Rico.

Giovani: Okay. When where do you currently live?

00:01:54

Yeandres: Right now, I live at Mayaguez, Puerto Rico because of the university. But I still live in Toa Alta Puerto Rico since I was born because my parents live there. So, I visit them.

Giovani: You already mentioned that due to university, you live in Mayaguez. So, my follow up question is what do you do? As in what do you study? And so on.

Yeandres: I'm a student that studies electrical engineering and currently I- I'm at my fourth year of my bachelor.

Giovani: How are you doing in this time of the pandemic and in general with college and everything?

00:02:37

Yeandres: Right now, I think that I'm doing great besides past semesters because currently I have two jobs. One is work-study in the university and also have a job aside. But also, I'm currently having twelve credits in my um in this semester that includes um uh electrical systems analysis three, um systems and signals. And the other course is uh German and um linear algebra.

Giovani: Okay, thank you for that. Now that we have stated some general information about yourself, I would like to get into our main topic for this interview, which we have discussed before, prior to asking to interview you, which is your car accident. My first question relating to this topic is, can you provide the exact date of the accident?

Yeandres: January six of 2020 at 9 a.m.

00:03:49

Giovani: What were your thoughts during that morning?

00:03:53

Yeandres: Well, I have a mixture of um thoughts, ideas, uh reflections, so many things that pops up in my head at that moment. And I can say that I kind of feel blanked because everything happened so fast since even fo- since yesterday, even since that 7 a.m., 8 a.m., 10 minutes prior to the accident, it was so hectic, my mind at that moment and after the accident

that I survived, thank God um I can say that I have so many things to say but complicated to show them.

Giovani: Are you okay?

00:04:42

Yeandres: Right now, yes. Uh during the accident um, on- one month later, two months later, even a year later, I- I will say not. But right now, I'm currently great.

Giovani: Okay. Can you describe your car?

00:05:00

Yeandres: I have Ma - um Mazda. I don't remember the name exactly, of the model of the car, but I know there is a Mazda 2006. It's a it's a family car it uh-.

Giovani: That's okay. The name the name of the car is not important. Maybe just the color, the attachment, the use of the car, how old it was.

Yeandres: Yeah, it was from 2006 is. It's a blue car. I call it blue beetle. Um it also has some accessories that my dad gave me ah to the car for camping. I had like two camping sets uh rack in the hood of the car to move stuff. Yeah, I really like that car. I really have a pretty nice- [inaudible]. And also, my dad helped me a lot to um not only set it up, but also uh buy it um financially.

Giovani: Okay, I'm going to ask a question that I should have asked before when I mentioned how did you feel that morning? And it's that, we know that during that day there were earthquas-, earthquakes during the morning. How do you feel during th- the earthquakes, during and after you experienced them?

Yeandres: So, I was sleeping when the earthquakes happened and also, I have my mind scramble the day before. So, receiving that the earthquakes it was so shocking to me because that was the um- least ex- thing I expected from that day in *El dia de los Reyes Magos*, three kings' day, um thinking that it's going to be like a great day or also like trying to like um continue from a bad thing that happened the day before. So having that um [inaudible] the earthquake, it put me frightened and put me frenetic. Uh I rushed out of my apartment because I live in a third floor, so everything shakes very bad. Um and also it was the same day I wanted to see my my family because of the three kings' day. So yeah um, I feel that I rushed out without realizing that even though if it, if even like even- even if, like I clean my mouth or like take a shower quickly or like the simplest thing, I just ran out of my apartment.

Giovani: Yeah, I understand you mentioned that you were also startled, in a way, from the day before. What happened? The day before.

00:07:44

Yeandres: So, the day before um uh January five. It's also the festival um *Vispera de los Reyes Magos* [three kings day eve] um in Juana Diaz in the south part of Puerto Rico. Um I was there with my family because they were also celebrating at that festival. Um and also, I

visit them because I haven't seen them in a while because um prior to those dates I was like at my own doing my own stuff, trying to be independent, trying to get my own job that I was going to have an interview, uh a job interview at Chili's at Mayaguez on January seven. So, I was also studying for the exam, for the interview that prepare myself to get a job. So also, I was like excited and and have the emotions about that. And also, um [clicks tongue] in- in the in the [clicks tongue] winter vacation in Christmas, I spend a lot of time with my aunt, um part of my f- dad family um and not necessarily my own family, my parents. So, when I visit them, um I stay with them [inaudible] we just drink a little and eat some food. But I want to rush out because I left up some stuff at my apartment that really needed to get them um not necessary, like to to travel to move them to my house is that I really need them because of the job interview, because they are ganna like do stuff on my own. So, I rea- really need to rush to go back to my apartment to get the stuff. And it was like seven. No, it was like 8 p.m. So, I went to like leave early from the festival and my dad wasn't loving the idea and he was in denial. So, he said to me no to go. But I insisisted because I really needed to do it. Because, like I cannot leave that important paper that um the repaso [review]? I couldn't leave it to because I needed to study for the interview. Um so my dad was getting cranky because he he likes to drink a lot. And he also like ge- he's kind of like an alcoholic. So, he was getting drunk at that day, and he raised his tone to me saying that I won't drive back to my apartment, and I will stay with him. And going back to home um for Three Kings Day. And I didn't like that. So, I asked for my uncle that he has a house nearby in the festival. That was my car parked there, so uh my uncle was in favor for my dad's side um of the decision of me leaving. So, after that my dad start yelling me and insulting me some bizarre stuff in front of people while drunk um that I will not leave the I will stay together as a family. Seen like a- he's also like he tried to say that if it's like he was in the right or like he was trying to like save the family because I will stay with him. And also, that was so wrong because it felt me so uncomfortable. I feel insulted um in front of everyone, embarrassed. So, at that moment I just ran and went from the house for my uncle and stay there crying. Um and one and a half hour later, 2 hours later, um they arrived, and my dad was more calm and there was like also my grandma and my mom, my uncle. And they said, oh, you can go whatever. You can go to your apartment, but you need to stay there and not travel at the midnight to your home in Toa Alta. Um and really wanted to do that because I'm ni- more like a night person, so I can like drive at night I'm not so much a morning person, so uh but I listen to them because to to please them because of the shenanigans. And um outrage that my dad cause. So, I leave there at 10 p.m. and arrive around 12 a.m. at 12 of the morning at my apartment and I fell asleep. So, when I woke up at January six, I was thinking, all the situation of the day before that I had a fight with my parent because I think that he fight because um I haven't stayed with him with a while and I was trying to do my things at my own. An- and I think that he doesn't like that because he's like a person that likes to manipulate or control one a lot, asking a lot of favors, a lot of a lot, a lot of favors and not stopping with them and thinking that everything's going to be all right, because I want to do my own things. Like, he thinks that I have ev- everything for him and let's not like that. I'm studying. I'm starting to work. I need to be independent like he is, but he doesn't seem like that. So, when I wake up at the earthquakes. Yeah. Once they get all that bad things that the day before and the earthquake really put me mad. Um uh I was also sleepy because I was um, I guess um I wa- I sleep at 10:12 a.m. and well, when I [sighs] when I started driving to go to my home at Toa Alta, I ran so quick because of the earthquake, because of the situation. And nah, it really put me very upset at that day.

Giovani: Okay. You mentioned that your father helped you get some things for your car. And you also mentioned that he mentioned he said he spoke some bizarre comments towards directed at you during the party. Would you emphasize on that? Would you comment on what those bizarre comments were and try to describe what you consider is your relationship with your father? Is it a good relationship? Is it bad that he help you with your car because he wanted to or because he had to? Because you're his kid?

Yeandres: Well, he helped me to get my car. And I think because he had to because I'm his kid and unnecessary. Because I wanted to. Because I raised my own money to buy my own car. I have like around 2000 and a half um US dollars. But he wanted to put the same amount that I have to buy a good-looking car. And I didn't want that because I was pleased to have a normal or used cheap car. But he wanted to give that extra mile because he thinks that I'm his um, let's say daddy's um perfect son, whatever. Because I study electrical engineering. Um My dro- my brother is a dropout. Um my sister studies microbiology um its- she's studying for um to be a nurse. So, my dad hasa has a dream to be an electrical engineer. He's like an electrician but is not an engineer. So, he seems to me like a prized possession. So, if I can ask him something that I really need or um uh um that I really need, he will help me. But he will also like take advantage of me for doing so.

Giovani: Oh, like, want something in return?

00:16:08

Yeandres: Exactly. Company or.

Giovani: A favor.

Yeandres: Mua- It's more likely labor work

Giovani: okay.

00:16:19

Yeandres: Because he also like he has a job in called Pfizer. Um he's like uh electrician of the machine that operates the uh refills of the prescribed medicines. But also, he has two side jobs that are um garage door repairman and installation and AC, that is air conditioning, installation, and repairman. So, he I have a dream to like have his own company. But um his brother couldn't. They didn't want to help them to have his own, AC and garage door company. So, he always use my me and my brother to [inaudible] to do those side jobs. But he uh he's a very workaholic man. So, he he always went to have the perfect job with a perfect timing, with a perfect stuff. If you do one mistake, he will yell at you. He will insult you and say that it's your he his, your wrong, he- you're wrong. But if he makes a mistake, al- all is good, all is clear. So, the work continues. And and sometimes even though that he's wrong in the smallest like the wrong screw for the garage store or the cables are put wrong, or I couldn't give him the tape because I was doing something else. He always tried to blame someone and not blame himself. And since I remember from my memory, he didn't do that a lot. But time passed on and he started to like blame more to others than himself. Seem like he's always right. So, my relationship with my dad that caused those nasty comments, like he

tries to manipulate me and control me looking that I'm wrong and he's right and I need to do what he says.

Giovani: And those comments originated because you didn't want to do what he told you to do.

00:18:21

Yeandres: Yeah, because I wanted to leave early to do my own stuff, to get my prepare my job interview. And he wanted to leave everyone um together to back to home for three kings' day. But I didn't wanna. I wanted to go on my own pace. I wanted to do my own stuff. And he got pissed and he sold me all of that.

Giovani: But were the comments only related to what you wanted to do, or were they more personal in a sense? Were they directed at a specific detail about yourself?

Yeandres: If I can say personal, I wouldn't say that because I was also like trying to avoid my father this vacation. I was spending more time with my aunt. So, he really get pissed for not contact him for not um I'm talking with him for not being present so much with him this vacation. So, I think that those comments he throw to me that were you're staying here right now. You're going to do what I say. I don't care if you had an interview. We're leaving right now. No, sorry. We're staying right now. We leave together in a very nasty way. I think it was because he was missing me. Because he wanted to um to use me or I don't know, he- he wanted me to be there, but in a wrong way.

Giovani: Does he usually yell at you when he gets drunk?

00:20:05

Yeandres: Um not even drunk? He always yells like drunk and not drunk. But when he gets drunk, he always throws those subtle comments that always um throws you off because they're comments that are being just hurtful, like being, oh, uh you don't understand what I say, or you always being so stupid or nobody understands what I said. You need to do it this way because this is my house and like you should do it this way or. Also, he's a very cranky man. Like if he this- doesn't eat anything, he always, like, start fighting for everything and blames you for everything. Like, an- I was studying on my um, my own. And he blames that there's no food in the house. Maybe you have your own money. You can buy your food for yourself in a fast food or try to learn to cook, try to do stuff to yourself. He always wants to do people to do stuff for him, and that's time consuming because his- he doesn't say thank you. He doesn't say uh please. It always says, do it now er- or I will get angry or cranky or I'll insult you.

Giovani: Did these arguments with your father start once he left for college, or were they present before?

00:21:25

Yeandres: Oh, since I was born like.

Giovani: [Chuckles]

00:21:26

Yeandres: There were always because when I was a kid, it was always um to do stuff that my dad likes, especially um um riding mountain bikes, BMX. Um it was a competition that before was kind of on the ground, that it was um bikes that you can ride in the four-by-four tracks while terrain he was his passion is are very passionate man about bicycles cycling and me and my brother and my sister didn't like that so he forced my brother to do it. And it was a bad experience because everyone was kind of sad, mad every time we go out on Sunday running, um riding bicycles because he's always forced it and not always ask for or um ask for it in a nice or kind way. Um years pass by. Um he thinks that I'm straight and he thinks that I'm his perfect son because I'm more kindly intrigued to technology and electricity. And he study um. He's an electrician. So, he seemed that way that I should like go to the- to the colegio [college] UPRM to study electrical engineering to fulfill his dream. And honestly, I think that it's still my dream, not his dream. Because I was fan of the electricity, I took engineering because I was like light shows, renewable energy and not to please him. And I think that he seems that way that he's going to be proud. That's I'm studying electrical engineering because when my brother study um microbiology and also psychology, he didn't mention that he's studying like you also mentioned, like, oh, he's doing his own thing. But when he talks about me, oh, my son Yeandres is studying electrical engineering in- in El Colegio. Uh he's in his second year. He was like, gave that extra talk to me instead of my brother or my sister are still doing their hard work. So, I feel that pressure on. So, he was so proud telling him that I was going to electrical engineering and at 12th grade that I know that I was going um to colegio. And and I knew that um things happens in the university. One explores his own sexualities, own identity. Um Its own mental issues and also outside issues, social issues. I knew that um I had me I needed to came out to my- to my parents, especially to my dad, because my dad is very homophobic. Uh well, I will not say homophobic. I will say very um mas- um. Conservative. He's very conservative. Um I don't know the word in English, but I will say machista [male chauvinist]. So, when I told him the news, um he get out rated, outrages so badly that he throws um stuff around the house. He has his own car with the garage door and the AC. He literally grab it and shake it and yell why- that my son is gay to all the neighbors. And then he um obligated me to tell my sister that I was gay. But she knew before him because I was was had. I was have a connection with my sister, so she was like, cool with it. So, he really go- I think I really got mad because everybody knew except him because I never had the confidence or the genuine connection to trust him, to tell him, because I knew he was ganna get upset and was ganna get mad because he put me like in a pillar and saying that he thinks that it's like a downfall. And he acted like if I was like a dumb fool. So, after he shaked the car, he throws stuff around the um the garage room. Um he got drunk. So drunk he drank a bottle of wine of my mother, and he passed out at the living room of my house and start [inaudible] there. And I was felt so disgusted that he insulted me, yell at me, tell him like I came up to him and he tell it to all the neighbors, putting me in that tough position, looking like I was being abused. And it was very difficult to me to see him then getting drunk for no reason and then being passed out like there. So, me and my mom carried him, taken to the shower with certain clothes off because he was still puking. And we lay him there with our shower running, puking. And so, because he he, he did that and we're not going to well he's, my dad. So, I still love him. And I tried to save him that moment, but I leave him with those shame on because it was so disgusting the way he treated me and also get into my mother because he yelled to my mother to stay back like looking at if I was like a danger or a conversation that she doesn't to belong. She doesn't need to belong there. It was a horrible experience. Well, after that day, my father didn't talk to me for two weeks. He almost even

didnt came to a house like he works like five p-, 5 a.m. of um um since-through Monday to Saturday. But he always arrived at from 2 p.m. to 4 p.m. But since that moment, those two weeks, he always arrived at 7 p.m., 8 p.m., almost 9 p.m. and he arrived to sleep to avoid me because yeah, I lived there. So yeah, it was a pretty difficult experience because he didn't, I don't know that he tried to avoid me because he was mad at me. I think oh uh um he was mad at me, but I don't think it was it was ifr- if he was ashamed of it or mad at me, didn't want to like throw a punch or do something. Um but after those two weeks, he said to me, I don't like um those stuff and I don't believe it, but I respect it. And still he tried to cope with it or to live with it, but I think that is still like he doesn't like accept me at all. So, uh that was like from 12th grade. Until this day things are better but not um perfect. I think that they're the same and also got affected even worse because of the car accident. Because he put me in a pillar for studying electrical engineering. And then after that car accident, um [clicks tounge] it was like a setback for him because he didn't um he didn't worry about my life. He worry about more of the money spent in the car, that the car was a total waste because the way that um I lost my car, the the car accident is that I was ex- um in a I was exceeding the velocity of the of the vehicle in en el tunel de Guajataca [in the tunnel of Guajataca] but.

Giovani: If I may, a little side note. If you feel like you're stuck and you need to say something in Spanish, you can. I'm the interviewer or you're the narrator. This is your story. You can say things however you want.

Yeandres: Thank you. So um when I was saying that the car accident occurred in *el tunel de Guajataca* [the Guajataca tunnel] at Isabella at 9 a.m., and it happened because I was exceeding the um the velocity of the car and I wasn't like paying attention of that because I was in my head thinking about the isult of my dad, the earthquake, trying to arrive at home as quickly as possible because of the um *dia de los reyes magos* [three kings day]. So, it also rained that there. So, in the hill of the street the car got stunk or the the wheel of the car-

Giovani: Got stuck?

00:31:03

Yeandres: It got stuck, and I couldn't, like, move at anything. And I was, like, slippering from right to left.

Giovani: How did you feel in that moment?

00:31:14

Yeandres: I was scared, but it was so quick that I couldn't even say that I was scared. I was shocked. Mostly I was shocked. But it'll happen like in a second since the wheel got stuck, and and second later I was like upside down from the car accident. And if and if and it happened because of giving those spins of the slippery um street of my car. Uh I give a 360 that I end up um *chocando con un poste de telefonica* [crashing with a telephone utility pole] and the car gave a 180 turn. And I end up upside down and the the crystal of the windshield the car the one of the front of the car blasted in, shattered through my face, and I end up having crystal pulverized crystals all over my head and my my head, my face, even my throat, my eyes. So, I was like in shock at that moment because I didn't know if if I- I know that I could move, but I didn't know if I should move because of a head injury, because

the accident was in the [clicks tongue] left side of the car that I was driving there. So, it was like at my door. So, I was like upside down. And after I will say 10 to 30 seconds, I rea-I realized that I was like upside down. And I started screaming, Help, help, somebody help. And um I also couldn't get down because I was like hanging out the seatbelt. And it was um, thank God, that two um bus two school buses were going to San Juan for a festival of dia de los reyes magos [three kings day], and they were having a lot of children. And in that bus, they had two um nurses that helped me to get off the car and also clean my eyes. So, because of her, I will say that they saved my vision, my eyes, and I'm also pretty grateful for that. Um then the police came. They check me if I was in drugs or always in something, and I did say no, I was all right. I cool. I could answer with great but I still I was in shock because of the car accident and thinking about how my dad was going to see me. So, they rushed me out to the hospital. Do me the MRI scan to see if I hav- have any internal bleeding or any problem [clicks tongue] and all came out um great. But still I was held in the hospital [clicks tongue]. So, my aunt, that is well, my si- I will say my second aunt because she's really the aunt of my father, the sister, my grandma, not necessarily my aunt, but also her aunt. So [clicks tongue] she rushed she rushed out to the hospital to see me and cry, help me out to see if I was okay. And all I felt such at peace having her there because and it was weird because she's not [clicks tongue] I haven't had so much time with my um [clicks tongue] my aunt compared to my parents and having those be the times this vacation with my aunt I- I felt so great and she helped me to retain that fear that my father gone- came to the hospital and when he came, he came with a hungover from the day before of the vispera de los reves magos [three kings day evel that he yelled at me taking some kind of meds to take out his uh hungover. I don't know, it was aspirin or what, but he looked like he was so messed up. And he was he rushed there to the hospital and again, he started yelling instead of saying that if I was okay, um.

Giovani: Where are you? Okay, did you suffer any major injuries?

00:35:35

Yeandres: Well, the only major injuries that I have, like problem with my vision, like um my eyes irritates a lot. So, and also my glasses I have to like um since then I changed the prescription like three times since 2020 um and still became. And now I use like four types or try- three types of medicines for my eyes. But besides that, I'm okay, um.

Giovani: No dislocated shoulder, knee? Nothing like that?

00:36:09

Yeandres: The only physical damage is for my eyeballs. But. But after that. No- Nothing else. Only my mental health. And. Yeah, so.

00:36:23

Giovani: And how was the experience with your father after he arrived at the hospital-

00:36:30

Yeandres: Hurtful.

00:36:30

Giovani: Compared with your aunt?

00:36:30

Yeandres: Oh, compared with my aunt. It was uh totally different because my aunt was caring, helpful, loving. Uh she tried to be calm that everything's um okay. Like, fuck the car.

We don't need that. It's only material um but my dad was very materialistic, caring about the car and unnecessary for me, insulting me, saying that. Why I did the- why did I incur the accident knowing that I can act like yes, I could control the speed um velocity of the car, but I couldn't control that maneuver when it got stuck and and also with a slippery wet. So it was shocking for me, like giving me a lot of excuses, insulting for not being great and trying to, like, avoid that moment. It was very triggering for me.

Giovani: You said that you could have controlled the speed limit at which you were driving but-

00:37:37

Yeandres: I could control, but I didn't control it because I was thinking all over my head-

00:37:41

Giovani: No, it's okay. I understand. But as I was ganna say, you could have controlled that. But you weren't in a right place. You were thinking about the earthquake. You were thinking about the day before with your father and the argument.

Yeandres: And the job interview of the-[inaudible].

00:37:57

Giovani: Yeah, all of those things where you were thinking about them, maybe you weren't thinking straight, you were just-

00:38:07

Yeandres: Yeah, I was-

00:38:07

Giovani: Thinking about what you were going to do.

00:38:07

Yeandres: I felt that I was I wasn't driving. I was trying to arrive as fast as possible.

00:38:14

Giovani: You felt numb?

00:38:15

Yeandres: I wouldn't say numb because I was uh.

00:38:23

Giovani: Did you feel like you were blank?

00:38:25

Yeandres: I was seein- I was seeing myself in a future. I will say like that, because if I will say I felt numb, it's like going straight ahead to the walls, to going straight ahead to uh electrical pulse. It wasn't like that.

Giovani: That's not what I meant. By numb. By numb. My men like you; you weren't focused on the road. You were just focused on your mind. You were lost in yourself.

Yeandres: Yes, yes, I was focus on my mind last thing the the day before, trying to see myself in the future, thinking of the job interview, thinking how can overpass

Background Noise: Loud rubber squealing from car tires.

00:38:58

Yeandres: that bad thing with my parents, with my dad. So yeah, I wasn't thinking of driving. I was trying to think what to do next.

Giovani: Yeah. So, in a sense, you were kind of overwhelmed.

00:39:12

Yeandres: Yes, I remember very overwhelmed and not paying attention to my surroundings.

Giovani: So, would you say that the discussion with your father the day before and the influence of the earthquake during the morning had a big impact?

00:39:25
